

## FEE POLICY (2022 – 2023)

## SCHOOL TUITION FEE

The School Tuition Fee must be paid basis the School Fee Schedule and the Due Dates as mentioned below:

TERM 1	1 <sup>st</sup> March 2022 to 31 <sup>st</sup> May 2022	Due Date : 21/04/2022
TERM 2	1 <sup>st</sup> June 2022 to 31 <sup>st</sup> August 2022	Due Date : 15/05/2022
TERM 3	1 <sup>st</sup> September 2022 to 30 <sup>th</sup> November 2022	Due Date : 15/08/2022
TERM 4	1 <sup>st</sup> December 2022 to 28 <sup>th</sup> February 2023	Due Date : 15/11/2022

**Please Note:** The above Fee Structure is only the Child's School Tuition Fee Schedule. All other Fees and Charges shall be applicable as additional Fees and Charges for the Child through the Academic Year.

• The School Fee payment is to be made Online via the HDFC Internet Banking Gateway using the Child's Registered Code.

• The School Fee and the School Fee Schedule are subject to change as per the rules and regulations prescribed by the Government and or the School.

• The Parent must be careful while remitting the School Tuition Fee. If the Parent makes a mistake and remits School Tuition Fee incorrectly, then the School shall be unable to reimburse the excess amount.

• Any failure towards payment of School Fee to the School by the Due Date mentioned in the School Fee Schedule will result in Late Fee payment, which shall amount to **Rs.100/- per day**. If the Parent fails to remit the School Fee and the Late Fee within 30 days from the Due Date, the School holds the right to deny Admission to the Child.

• The QFix Payment Gateway for the Child shall be deactivated upon Non-Payment of the School Fee of the Child, and the School holds the right to deny Admission of the Child.

• The School requests all Parents to kindly Download or Save or Print the School Tuition Fee Receipt directly from the HDFC QFix Portal immediately after the Payment has been completed. The School shall be unable to do the same on behalf of the Parent.

• If the Child leaves the School, the School Tuition Fee once paid is non-refundable under any circumstance. The School will issue the Leaving Certificate only after the Parent settles all the dues.

• The School can only accept the School Tuition Fee Payment through the HDFC Internet Banking Gateway - QFix.

• Payment made on the School Fee Portal through the HDFC Internet Banking Gateway via Credit Card (Visa, Master, and Diners) will levy an additional charge of 1.10% on the Total Transaction Amount.

• Payment made on the School Fee Portal through the HDFC Internet Banking Gateway via any Debit Card will levy an additional charge of 0.75% for value  $\leq$  INR 2,000 and 1.00% for values > INR 2,000.
